ARTICLE II. PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III. PURPOSE

The specific purpose for which the corporation is organized is: "Winds of Revival is an interdenominational ministry whose purpose is to motivate believers in Christ to develop a deeper and more intimate relationship with the Savior, to live holy lives before God, and to have an unceasing desire to live each day walking like Jesus walked; understanding that those that live this way will be instruments of God to bring revival to His church in this generation."
