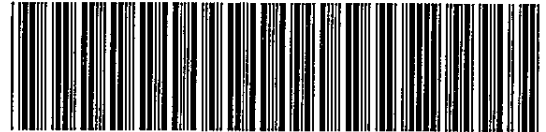

ARTICLE I. NAME

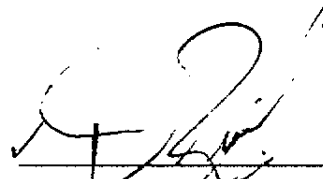

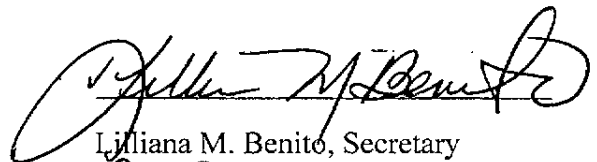

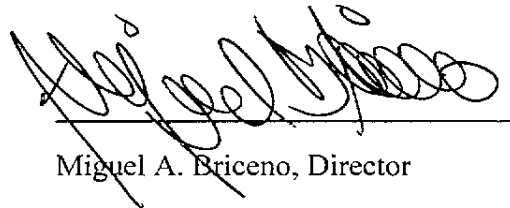
