1. **NAME:** The name of this corporation is: EliteCorp, Inc. (a non-profit corporation)
2. **PRINCIPAL OFFICE ADDRESS:** The principal address for the corporation is: 7029 Pelican Island Dr., Tampa, Florida 33634-7422
3. **THE PURPOSE:** The purpose of this corporation is established as a Florida State Non-for-Profit business development organization under the General Corporation Law of Florida.
