ARTICLES OF INCORPORATION

OF

A Florida corporation not for profit

ARTICLE 1 NAME

The name of this corporation is: National Coalition of Esthetic & Related Professional Associations, Inc.

ARTICLE 2 DURATION

The duration of this corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of the articles of incorporation by the Department of State of the State of Florida.

ARTICLE 3 GENERAL PURPOSES

The Corporation is organized to form a business league within the meaning of Internal Revenue Code Section 501(c)(6), for exclusively charitable purposes including the fostering of the common business interests of individuals and organizations in various fields of esthetic science.
