ARTICLES OF INCORPORATION

Of

We the undersigned acting as incorporators do hereby subscribe these Articles of Incorporation for the purpose of forming a non profit corporation under the laws of the State of Florida, Chapter 617, and subject to the following provisions.

ARTICLE ONE

The name of the corporation shall be:

Vertex Technological Institute, Inc.

The principal place of business of this corporation shall be:

1400 South Dixie Highway Pompano Beach, Florida 33060

Other offices for the transaction of business may be located wherever the President or Vice President may deem necessary or expedient.

ARTICLE TWO

This corporation shall be perpetual existence unless dissolved according to law and shall engage in any activity or business permitted a non-profit entity under the laws of the United States, of the State of Florida and within the restrictions of Internal Revenue Code 501(C)(3).

ARTICLE THREE

The purpose of which the corporation is organized is: This is a non-stock, non-profit corporation. This corporation will engage in, but shall not be limited to a computer-skills training center.

The purposes for which the corporation is organization are exclusively charitable, scientific, literary, and educational within the meaning of section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. Said corporation is organized exclusively for charitable, religious, and educational purposes including, for such purposes, the making of distributions to organization that qualify as exempt organizations under Section 501(C)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States

Internal Revenue law. Notwithstanding any other provision of these articles, the organization shall not carry on any activities that are not permitted by an organization exempt from Federal income tax under section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on, (a) by a corporation exempt from Federal income tax under Section 501(C)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code or (b) by a corporation contribution to which are deductible under Section 170 (C)(2) of the Internal Revenue Code.

No part of the net earnings of the corporation shall inure to the benefits of or be distributable to its members, trustees, directors, officers or any private persons, except that the corporation shall by authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of Section 501(C)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

ARTICLE FOUR

The qualifications for members and the manner of their admission are: The conditions for membership shall be stated in the bylaws.

ARTICLE FIVE

The corporation shall have (3) Directors initially. The numbers of Directors may be increased or decreased from time to time in such a manner as may be prescribed by the By-Laws, but shall always be at least one (1), but not more than seven (7).

The corporation shall indemnify and hold harmless each person who shall serve at any time hereafter as a director or officer of the corporation, and serves at the request of this corporation, as a director or officer of any other corporation from and against any and all claims and liabilities to which such person shall become subject by reason of his having heretofore or hereafter been a director of officer of this corporation, or by reason of any action alleged to have been heretofore or hereafter taken or omitted by him as such director or officer and shall reimburse each such person for all legal and other expense reasonably incurred by him in connection with any such claim or liability provided that no person shall indemnified against, or be reimburse for, any expense incurred in connection with any claim or liability as to which it shall be adjudge that such officer or director is liable for negligence or willful misconduct in the performance of his duties.


