ARTICLES OF INCORPORATION OF BYRON BLEDSOE EVANGELISTIC ASSOCIATION, INC.

The undersigned, being of legal age and competent to contract, for the purpose of organizing a not for profit corporation pursuant to the laws of the State of Florida, hereby adopts the following Articles of Incorporation, and hereby agrees and certifies as follows:

ARTICLE I

The name of the Corporation shall be BYRON BLEDSOE EVANGELISTIC ASSOCIATION, INC., whose principal office shall be located at 8801 El Prado Avenue, Orlando, Florida 32825, and whose mailing address shall also be located at 8801 El Prado Avenue, Orlando, Florida 32825.

ARTICLE II COMMENCEMENT OF CORPORATE EXISTENCE

This Corporation (the "Corporation") shall commence corporate existence immediately upon the execution of these Articles and shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III PURPOSES

- (a) This Corporation is created to engage in, assist and contribute to the support of exclusively religious, charitable or educational activities and projects which are duly authorized to carry on such activities and which have established their tax exempt status under the provisions of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended or replaced from time to time (the "Code") and its regulations as they now exist or may hereafter be amended, and the property, assets, profits and not income of this Corporation are irrevocably dedicated to such purpose.
- (b) The specific purpose of this Corporation shall be to glorify God and His Son, Jesus Christ, by contributing resources to such individuals and entities as are effectively proclaiming through thought, word and deed the good news of the Kingdom of God in Jesus

Christ. This Corporation shall participate in no activity which shall not be directly in furtherance of said specific purpose.

- (c) In support of such purpose, the activities of the Corporation shall include:
- (1) To transmit the Gospel of the Lord Jesus Christ by public evangelistic meetings and by radio, television, and other media.
- (2) To spread the Gospel of the Lord Jesus Christ through books, tracts, and other publications.
- (3) To spread the Gospel of the Lord Jesus Christ by establishing or aiding educational institutions or organizations which subscribe to, teach, and attempt to transmit the Gospel of the Lord Jesus Christ.
- (4) To engage evangelists and speakers, and to conduct crusades, revivals and other programs for the advancement of the Gospel of the Lord Jesus Christ.
- (5) To print and publish books, records, tracts, treatises, and otherwise disseminate information on the Gospel of the Lord Jesus Christ.
- (6) To spread and propagate the Gospel of the Lord Jesus Christ by any and all other means.

ARTICLE IV GENERAL POWERS

This Corporation shall have all of the powers enumerated for corporations in the Florida Not For Profit Corporation Act, as it now exists and as hereafter amended, and all such other powers as are permitted by applicable law, including, without limitation and only by illustration, the following powers unless later restricted by applicable law:

- (a) To have succession by its corporate name for the duration of its existence.
- (b) To sue and be sued and appear and defend in all actions and proceedings in its corporate name to the same extent as a natural person.
- (c) To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced. The corporate seal shall be circular with the words "Outreach International Ministries, Inc." around the outer circle, and the words "corporation not for profit" in the inner circle.
- (d) To purchase, take, receive, lease, take by gift, devise or bequest or otherwise acquire, own, hold, improve, use, and otherwise deal in and with real or personal property or any interest therein, wherever situated.

- (e) To sell, convey, mortgage, pledge, create security interests in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets.
- (f) To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
- (g) To make donations for the public welfare or for religious, charitable, scientific, educational, or other similar purposes.
- (h) To increase, by a vote of its members cast as the bylaws may direct, the number of its directors, so that the number shall not be less than three but may be any number in excess thereof.
- (i) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise sell and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, whether for profit or not for profit associations, partnerships or individuals, or direct or indirect obligations of the United States or of any other government, state, territory, governmental district, or municipality or of any instrumentality thereof.
- (j) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as it may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.
- (k) To conduct its affairs, carry on its operations, and have offices and exercise the powers granted by the Florida Not For Profit Corporation Act in any state, territory, district, or possession of the United States or any foreign country.
- (i) To elect or appoint officers and agents and define their duties and allow them reasonable compensation.
- (m) To adopt, change, amend and repeal bylaws, not inconsistent with these Articles of Incorporation or with the laws of the State of Florida, for the administration and regulation of its affairs and the exercise of its powers.
 - (n) To have and exercise all powers necessary or convenient to effect its purpose.
- (o) To merge and consolidate with other corporations both for profit and not for profit, domestic and foreign, provided that the surviving corporation is a corporation not for profit.

(p) To receive and maintain funds of real and/or personal property and, subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom or the principal thereof exclusively for evangelical, charitable, literary, or educational purposes either directly or by contributions to organizations that qualify as exempt organizations of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

ARTICLE V PROHIBITED ACTIVITIES

The Corporation shall not allow any expenditure of any part of the net earnings of the Corporation to inure to the benefit of any member, director or officer of the Corporation (except that reasonable compensation may be paid for services rendered to or for the Corporation effecting one or more of its purposes), nor shall any member, director or officer of the Corporation, or any private individual, be entitled to share in the distribution of any of the Corporation's assets on dissolution of the Corporation, or shall a substantial part of the activities of the Corporation be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate or intervene (including the publication and distribution of statements) in the political campaign on behalf of any candidate for public office. Provided, further, that if at any time the Corporation is deemed to be a Private Foundation as defined by Section 509 of the Code, then for so long as the Corporation is deemed a Private Foundation, the following provisions shall also be applicable:

- (a) The Corporation shall not engage in any act of "self-dealing" as defined in Section 4941(d) of the Code.
- (b) The Corporation shall not retain any "excess business holdings" as defined in Section 4943(c) of the Code, which would give rise to any liability for the tax imposed by Section 4943(a) of the Code.
- (c) The Corporation shall not make any investments which would jeopardize the carrying out of any of its exempt purposes or in such manner as to subject it to tax under Section 4944 of the Code.
- (d) The Corporation shall not make any "taxable expenditures" as defined in Section 4945(d) of the Code, which would give rise to any liability for the tax imposed by Section 4945(a) of the Code.
- (e) The Corporation shall distribute its income for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942(a) of the Code.

ARTICLE VI DISTRIBUTION UPON DISSOLUTION

Upon the dissolution, the winding up of the affairs of the Corporation and the liquidation, the assets of the Corporation shall be distributed exclusively to the charitable and religious organizations as the Board of Directors shall determine, provided that such organizations are then qualified under the provisions of Section 501(c)(3) of the Code, and engage in the same type of religious or charitable purposes as the BYRON BLEDSOE EVANGELISTIC ASSOCIATION, INC.

ARTICLE VII MEMBERSHIP

The members of this not for profit corporation, if any, shall be qualified and admitted as set forth in the Bylaws of this Corporation.

ARTICLE VIII REGISTERED OFFICE AND AGENT

The registered office of this Corporation shall be located at 8801 El Prado Avenue, Orlando, Florida 32825, and the registered agent of the Corporation at that address shall be Byron Bledsoc. The Corporation may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Incorporation.

ARTICLE IX INITIAL BOARD OF DIRECTORS

This Corporation shall have ten (10) directors initially. The directors shall be elected and the number of directors may be either increased or diminished from time to time as provided in the Bylaws. The names and street addresses of the initial directors of this Corporation are:
