The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be:

METAMORPHOSIS CULTURAL & ECONOMIC DEVELOPMENT CORPORATION

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 601 N. Fig Tree Lane, Plantation, FL 33317

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is: to unify the Caribbean Community by facilitating the integration and coordination of transition services, while focusing on Caribbean students who come to South Florida to study and immigrants seeking to establish roots in our community. These services will also be available to general members. Metamorphosis Cultural & Economic Development Corporation will function as an information and support network. A collaborative effort between community volunteers, executives, professionals, and entrepreneurs representing various South Florida organizations. The introduction of a Steel Orchestra and other cultural arts will fulfill a void in our community by providing a venue where Caribbean people and friends alike can gather in a nice cultural atmosphere.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows: Initial Directors are appointed by President/Founder. Election shall be made by majority vote of the Directors. This provision may be ratified by new laws adapted by the Board of Directors.

The number of directors constituting the initial board of directors is three, and the name and address of the person or persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:

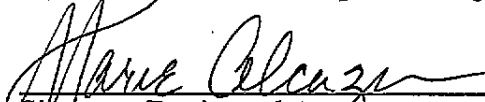
