The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the corporation is **Seabreeze Track Boosters, Inc.**

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation is **2700 North Oleander Avenue, Daytona Beach, FL 32118.**

**ARTICLE III: PURPOSE**

The specific nature of business of this non-profit corporation is to raise money to support the track program at Seabreeze High School.

**ARTICLE IV: QUALIFICATION**

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.
