ARTICLES OF INCORPORATION OF EXCELLENCE WITH CARING LEARNING ACADEMY, INC.

A NOT FOR PROFIT CORPORATION

We, the undersigned do hereby join together in the formation of a non-profit corporation, following the terms and conditions, to wit:

ARTICLE I

This corporation will be entitled 'EXCELLENCE WITH CARING LEARNING ACADEMY, Inc.', with a principal place of business located at 503 W. Edgewood Ave., Jacksonville, Florida 32208.

ARTICLE II

This corporation is a non-profit corporation organized under Chapter 617, Florida Statues. It is not organized for the private gain of any person.
