The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III - PURPOSE(S)

The specific purpose(s) for which the corporation is organized is to promote amateur swimming by:






