**ARTICLES OF INCORPORATION
OF
FAMILY AND YOUTH HELP CENTER, INC.
A NOT-FOR-PROFIT CORPORATION**

The undersigned incorporator, desiring to form a corporation not for profit under Chapter 617, Florida Statutes, as amended, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be FAMILY AND YOUTH HELP CENTER, INC., A NOT FOR PROFIT CORPORATION, which is hereinafter referred to as "the Corporation".

**ARTICLE II
PRINCIPAL OFFICE**

**ARTICLE III
