- Article I Name: StarCoast-a distance learning Academy. Inc

This corporation is organized exclusively for educational and charitable purposes within the guidelines of Section (501)(3) of the Internal Revenue Code.  3. additional opportunities for incarcerated students and students under juvenile justice jurisdiction
