# ARTICLES OF INCORPORATION OF US/CUBA LEGAL FORUM, INC.

SECRETARY OF STATE TALLAHASSEE FLORIDA The undersigned, for the purpose of forming a Nonprofit Corporation under Florida Statutes Chapter 617, do hereby make and adopt the following Articles of Incorporation.

### ARTICLE I NAME

The name of the proposed Corporation is: US/CUBA LEGAL FORUM, INC.

### ARTICLE II NOT FOR PROFIT

The Corporation is a Nonprofit Corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Directors or Officers, except to the extent permissible under the law.

### ARTICLE III DURATION

The duration (term) of the Corporation is perpetual.

### ARTICLE IV PURPOSES

The Corporation is exclusively organized, and shall be operated exclusively for following:

- 1. To contribute to the development of normal legal relations between the Republic of Cuba and the United States of America by means of seminars, conferences, publications, reunions, discussions and legal contracts.
- 2. To study the legal system of the Republic of Cuba by means of seminars, conferences, publications, reunions, discussions and legal contacts.
- 3. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

### ARTICLE V LIMITATIONS

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, Directors, or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 4 hereof.

### ARTICLE VI MEMBERS AND INCORPORATORS

Membership in the Corporation shall be open to individuals and entities that support the purposes of the Corporation. The By-Laws shall establish the rules of membership. The Corporation shall have Voting Members who shall be elected and may be removed by the Voting Members and shall have all the rights and privileges of members of the Corporation. The By-Laws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the By-Laws, but who shall not have the right to vote.
