The selection decision of new members should be based on the conditions set forth in the Committee Membership and a majority of votes by the members as follows:

- (a) If the total number of the committee is six, four votes are the minimum necessary for approval.
- (b) It the total number of the committee is five, three votes are the minimum necessary for approval.

The Committee member shall be permanently assigned and will keep his official capacity as an Executive as long as he meets the qualifying conditions set forth in the Committee Membership.
