## ARTICLES OF INCORPORATION FOR PROJECT 7, Inc.

### ARTICLE I NAME

The name of this association is PROJECT 7, Inc.

### ARTICLE II PRINCIPLE OFFICE

The principal office for the transaction of the business of this corporation is located at 4183 Old Mill Cove Trail West, Jacksonville, FL 32277

### ARTICLE III PURPOSE

"The purpose this corporation shall be to minister to young people between the ages of 13 and 18. To be a source of help and inspiration that will be a positive influence upon their lives through music, dance, peer to peer relationship building, peer to peer ministry, and any such other methods as may prove useful and in accordance with the Word of God. To engage in and carry on all kinds of Home and Foreign missionary work, to publish literature, to establish and conduct schools and institutes, and to engage in any related activities to help spread the Gospel".

The corporation shall include, but not be limited to, eleemosynary activities as a non-stock corporation not for profit in nature serving its members and the general community at large. Funds received through various programs and fund raising events are to be cycled through the corporation for the support of the operational cost (including salaries, utilities, etc.), Administrative costs (salaries for officials, plus insurance, housing, and costs for travel incident to corporate business), and Educational development to up-grade performance levels, and rehabilitational services by and through the operation of Thrift Stores, Book Stores, and any other lawful undertaking for the purpose of generating funds to promote said programs. It is the central most objective of the corporation to reach people through the facilities of the various programs for the express purpose of bettering their lives through the expression of the Gospel of Jesus Christ. The corporation shall aggressively seek to serve the community and the public at large through the various programs and endeavors, plus the out-reach methods of printed material and other public media, and the levels of the Spiritual, Socio-psychological, and Physical needs. The above stated Objectives and Purposes of the corporation reflect the intent, Defacto and Dejure, in the origin of this organization, and shall be guiding factors of the future operation, as in the past. Further, the services of the corporation shall be open to members of all races, sexes, and national origins without discrimination against their rights to life, liberty and pursuit of happiness.

### ARTICLE IV MANNER OF ELECTION

The Chairman of the Board shall be appointed for life. All Board Members shall be appointed by the Chairman of the Board and voting members in good standing. Any member not in agreement with this ministry is automatically terminated as defined in our Constitution. Upon the death, resignation or incapacity of a Board Member, a new Board Member will be elected by a majority of the remaining Board Members.

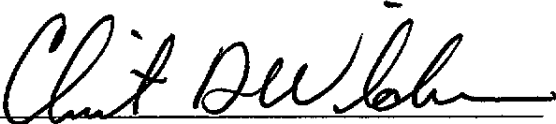
