ARTICLE I
NAME

The name of the corporation shall be:
Miami Domestic Violence Project, Inc.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III
PURPOSE

This corporation is organized exclusively for charitable, and educational purposes, more specifically to provide information, education and resources to victims of Domestic Violence. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE IV
MANNER OF ELECTIONS OF DIRECTORS

The manner in which the directors are elected or appointed will be set forth as stated in the bylaws of the corporation. The corporation shall have the number of directors specified in the by-laws. The number of directors may be either increased or decreased from time to time, in the manner provided in the by-laws.
This corporation reserves the rights granted by Section 607.0732(1)(a) of the Florida Statutes, as presently enacted, of eliminating the board of directors or of restricting its discretionary powers.

ARTICLE V
LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in the section 617.0302 of the Florida Statutes.




