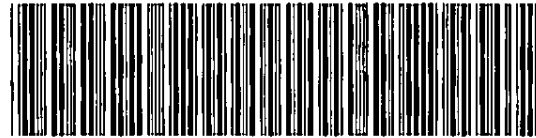



ARTICLES OF INCORPORATION

Pursuant to Chapter 617, Florida Statutes, the Articles of Incorporation of Tiburon Mid-Rise Neighborhood Association, Inc., a Florida corporation not for profit, which was originally incorporated as Ventanas at Tiburon Community Association, Inc. on March 26, 2001 and renamed Tiburon Mid-Rise Neighborhood Association, Inc. on October 13, 2005 are hereby amended, and restated in their entirety as amended. All amendments included herein have been adopted pursuant to Chapter 617, Florida Statutes, and there is no discrepancy between the corporation's Articles of Incorporation as heretofore amended and the provisions of these Amended and Restated Articles other than the inclusion of amendments adopted pursuant to Chapter 617, Florida Statutes and the omission of matters of historical interest. The Amended and Restated Articles of Incorporation of Tiburon Mid-Rise Neighborhood Association, Inc., shall henceforth be as follows:

**ARTICLE I**

**NAME:** The name of the corporation, herein called the "Association," is Tiburon Mid-Rise Neighborhood Association, Inc., and its address is 2727 Tiburon Blvd. East, #302, Naples, Florida 34109.

**ARTICLE II**

**PURPOSE AND POWERS:** The purpose for which the Association is organized is to provide an entity pursuant to the Florida Condominium Act for the operation of Tiburon Mid-Rise Lands and Common Areas and all improvements thereon, located in Collier County, Florida.

The Association is organized and shall exist on a non-stock basis as a corporation not for profit under the laws of the State of Florida, and no portion of any earnings of the Association shall be distributed or inure to the private benefit of any member, Director or officer of the Association. For the accomplishment of its purposes, the Association shall have all of the common law and statutory powers and duties of a corporation not for profit under the laws of the State of Florida, except as expressly limited or modified by these Articles, the Declaration of Covenants and Restrictions, the Bylaws or Chapter 718, Florida Statutes, as they may be amended from time to time, including but not limited to the following:

- (A) To make and collect assessments against members of the Association to defray the costs, expenses and losses of the Association, and to use the funds in the exercise of its powers and duties.
- (B) To protect, maintain, repair, replace and operate the Association property.

(C) To purchase insurance upon the Association property for the protection of the Association and its members.

(D) To reconstruct improvements after casualty and to make further improvements of the Association property.

(E) To make, amend and enforce reasonable rules and regulations governing the use of the common areas, and the operation of the Association.

(F) To enforce the provisions of the Condominium Act, the Declaration of Covenants, these Articles, the Bylaws and any Rules and Regulations of the Association.

(G) To contract for the management and maintenance of the Association property, and to delegate any powers and duties of the Association in connection therewith except such as are specifically required by the Declaration of Covenants to be exercised by the Board of Directors or the membership of the Association.

(H) To employ accountants, attorneys, architects, and other professional personnel to perform the services required for proper operation of the Association property.

(I) To enter into agreements, or acquire leaseholds, memberships, and other possessory, ownership or use interests in lands or facilities such as country clubs, golf courses, marinas, and other recreational facilities. It has this power whether or not the lands or facilities are contiguous to the Association property, if such agreements or use interests are intended to provide enjoyment, recreation, or other use or benefit to the unit owner members.

(J) To borrow money, if necessary, to perform its other functions hereunder.

All funds and the title to all property acquired by the Association shall be held for the benefit of the members in accordance with the provisions of the Declaration of Covenants, these Articles of Incorporation and the Bylaws.

### **ARTICLE III**

#### **MEMBERSHIP:**

(A) The members of the Association shall be the record owners of legal title to one or more units in the three (3) Condominiums lying within the Association property, as further provided in the Bylaws. After termination of the Condominium, the members shall consist of those who were members at the time of such termination and their successors in interest.

(B) The share of a member in the funds and assets of the Association cannot be assigned or transferred in any manner except as an appurtenance to his unit.

(C) The owner members of each unit, collectively, shall be entitled to one vote in Association matters. The manner of exercising voting rights shall be as set forth in the Bylaws.

## **ARTICLE IV**

**TERM:** The term of the Association shall be perpetual.

## **ARTICLE V**

**BYLAWS:** The Bylaws of the Association may be altered, amended, or rescinded in the manner provided therein.

## **ARTICLE VI**

### **DIRECTORS AND OFFICERS:**

(A) The affairs of the Association shall be administered by a Board of Directors consisting of the number of Directors determined by the Bylaws, but not less than five (5) Directors, and in the absence of such determination shall consist of five (5) Directors.

(B) Directors of the Association shall be elected by the members in the manner determined by the Bylaws. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided by the Bylaws.

(C) The business of the Association shall be conducted by the officers designated in the Bylaws. The officers shall be elected each year by the Board of Directors at its first meeting after the annual meeting of the members of the Association, and they shall serve at the pleasure of the Board.

## **ARTICLE VII**

**AMENDMENTS:** Amendments to these Articles shall be proposed and adopted in the following manner:

(A) Proposal. Amendments to these Articles may be proposed by a majority of the Board or by written petition, signed by at least one-fourth (1/4th) of the voting interests.

(B) Procedure. Upon any amendment to these Articles being proposed by said Board or unit owner members, such proposed amendment shall be submitted to a vote of the owner members not later than the next annual meeting for which proper notice can be given.

(C) Vote Required. Except as otherwise provided by law, or by specific provision of the condominium documents, these Articles of Incorporation shall be amended if the proposed amendment is approved by at least a majority of the total voting interests (at least 87) voting, in person or by proxy, at any annual or special meeting called for the purpose and at least a majority of those who voted for the proposed amendment from each of the three (3) affiliated associations (Ventanas, Esperanza I and Esperanza II) voted in favor. Alternatively, amendments may be adopted without a meeting following the procedure set forth in Section 3.12 of the Bylaws.

(D) Effective Date. An amendment shall become effective upon proper filing with the Secretary of State and recording a certified copy in the Public Records of Collier County, Florida, with the same formalities as required by law for recording an amendment to the Bylaws.

## **ARTICLE VIII**

**INDEMNIFICATION:** To the fullest extent permitted by Florida law, the Association shall indemnify and hold harmless every Director, officer and volunteer of the Association against all expenses and liabilities, including attorneys' fees, actually and reasonably incurred by or imposed on him in connection with any legal proceeding (or settlement or appeal of such proceeding) to which he may be a party because of his being or having been a Director, officer or volunteer of the Association. The foregoing right of indemnification shall not be available if a judgment or other final adjudication establishes that his actions or omissions to act were material to the cause adjudicated and involved any of the following:

(A) Willful misconduct or a conscious disregard for the best interests of the Association, in a proceeding by or in the right of the Association to procure a judgement in its favor.

(B) Violation of criminal law, unless the person seeking indemnification had no reasonable cause to believe his action was unlawful or had reasonable cause to believe his action was lawful.

(C) A transaction from which the person seeking indemnification derived an improper personal benefit.

(D) Recklessness, or an act or omission which was committed in bad faith or with malicious purpose or in a manner exhibiting wanton and willful disregard for human rights, safety or property, in an action by or in the right of someone other than the association or a member.

In the event of a settlement, the right to indemnification is subject to the finding by at least a majority of the disinterested Directors that the settlement is in the best interest of the Association. The foregoing rights of indemnification shall be in addition to and not exclusive of all other rights to which a Director or officer may be entitled including rights under an Association Directors' and Officers' liability insurance policy, if any.

**CERTIFICATE**

The undersigned, being the duly elected and acting President of Tiburon Mid-Rise Neighborhood Association, Inc., hereby certifies that the foregoing Articles of Incorporation were approved and adopted by two thirds of the voting interests of the Association a meeting held on December 2, 2021 and reconvened on January 6, 2022 where a quorum was present, after due notice, in accordance with the requirements of the Articles of Incorporation for their amendment, and that said vote was sufficient for the amendment. The number of votes cast was sufficient for the amendment.

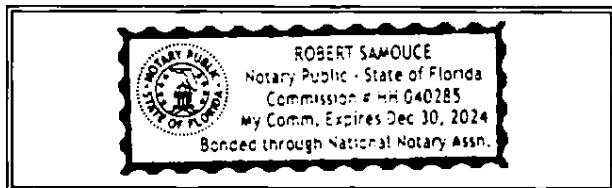

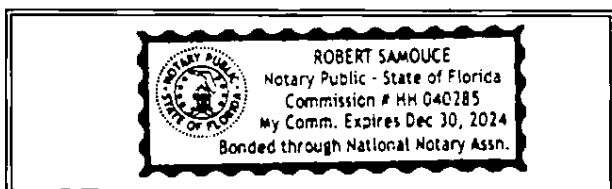
