

Pursuant to the provisions of Section 617.1006, Florida Not For Profit Corporation Act, the undersigned Florida not for profit corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is MISSION FOR MANKIND CHURCH OF DELIVERENCE OF CITRUS COUNTY, INC.
2. The Articles of Incorporation were filed on March 29, 2001.
3. Article One of the Articles of Incorporation is hereby amended in order to correct a scrivener's error in the corporation's name as follows:

ARTICLE I

The name of the corporation is MISSION FOR MANKIND CHURCH OF DELIVERANCE OF CITRUS COUNTY, INC.

4. Article Nine, Paragraph C. Adoption of Resolution By Board of Directors, of the Articles of Incorporation is hereby amended as follows:

ARTICLE IX, Paragraph C

C. Adoption of Resolution By Board of Directors - Pursuant to Florida Statute 617.1002, in order to amend these Articles of Incorporation the Board of Directors must adopt a resolution by quorum vote setting forth the proposed amendments and directing that it be submitted to a vote at a meeting of the members entitled to vote on the proposed amendment which may be either a regular or special meeting. Written notice of the proposed amendment or a summary of the changes to be effected by the amendment must be given to each member entitled to vote at such meeting in accordance with these Articles of Incorporation and the By-Laws.

These amendments were adopted on the 26<sup>th</sup> day of April, 2001, being duly approved by the members and the number of votes cast for the amendments was sufficient for approval in accordance with 617.1006, Florida Statutes.

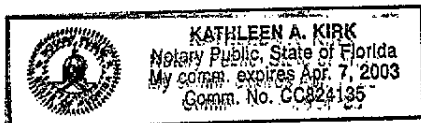

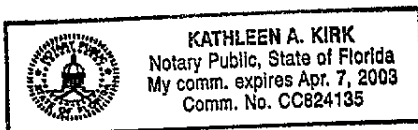
