ARTICLE I The name of the not-for-profit corporation shall be Lake Osborne Mobile Home Owners' Association, Incorporated.

ARTICLE II The address for the corporation is 2330 Lantana Road, 12B, Lantana, Florida 33462.

ARTICLE III The specific purposes for which the corporation is organized are: 1) the power to negotiate for, acquire and operate a mobile home park, now known as the Lake Osborne Trailer Ranch, 2330 Lantana Road, Lantana, FL, 33462, on behalf of the mobile home owners, 2) to ensure that we, as current mobile home owners are dealt with equally and not as individuals, and 3) to enable the legal protection of individual home owners in the case of any future law suits.
