

This agency will receive public contributions as its main avenue of support. We will continuously seek public assistance as defined in the previously mentioned IRS codes.

This agency will not discriminate against any persons that qualify based on policy underlying principle.

: In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501c3 and 170c2 of the internal revenue code of 1986 or corresponding sections of any prior or future internal revenue code, or to the Federal state, or local government for exclusive public purpose.

ARTICLE IV Delete original statement

The board of directors are appointed. The officers are elected by the board of directors. Officers will hold their position for two years. An officer or board member can be removed by majority vote if one's actions or posture jeopardizes or threatens the integrity of this agency.

The number of board members (governing body) of this agency will not be monopolized by any individual or special group interest. The board of directors (officers) must represent an objective decision making body presenting the best interest of the agency.
