Article I NAME

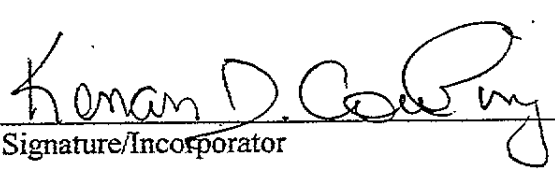
