ARTICLE I NAME

- No substantial part of the activities of the Corporation shall participate in, or intervene in 2. any political campaign on behalf of, or in opposition to, any candidate for public office, and
- Notwithstanding any other provision of these articles, the corporation shall not carry on 3. any other activities not permitted to be carried on by a Corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, as now enacted or herein amended.
- The Corporation shall not lend any of it's assets to any officer or director of this 4. Corporation, or guarantee to any person the payment of a loan by an officer or director of this Corporation.
