Articles of Incorporation for Life Preservation Society Inc.

Attachment A. for Article III Purpose

The Corporation is organized exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including for such purposes, the making of distributions to organizations that also qualify as Section 501 (c)(3) exempt organizations. The Corporation may receive and administer funds for charitable, educational, and scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986. To this end, the corporation shall promote the health and welfare of people, animals, and their environment. All funds, wether income or principal, and wether acquired by gift or contribution or otherwise, shall be devoted to said purposes.
