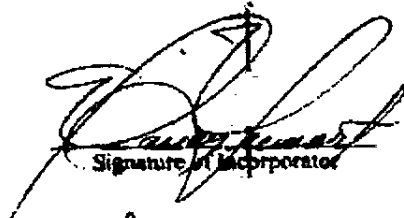
ARTICLE III :

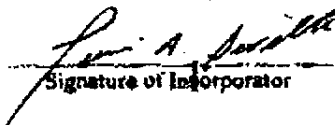
