#### ARTICLE III: Purpose of the Corporation.

The corporation is being organized as a non-profit corporation. The purpose of this corporation is to improve the sailing skills of amateur sailors in the Tampa Bay area of Florida through advanced training and education. By providing hands-on training of the necessary skills in advanced sailing vessels and emphasizing sportsmanship in competition, the foundation will develop the youth to be well-rounded competitors.
