**ARTICLES OF INCORPORATION OF  
WESTMINSTER CHRISTIAN SCHOOL FOUNDATION, INC.  
A FLORIDA CORPORATION NOT FOR PROFIT**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of the corporation is Westminster Christian School Foundation, Inc. (the "Corporation").

**ARTICLE II. PRINCIPAL OFFICE**




