ARTICLES OF INCORPORATION

THE UNDERSIGNED, ACTING AS INCORPORATION OF A CORPORATION PURSUANT TO CHAPTER 617, FLORIDA STATUTES, ADOPT(S) THE FOLLOWING ARTICLES OF INCORPORATION OF SUCH CORPORATION:

ARTICLE 1

THE NAME OF THE CORPORATION SHALL BE: SAVE FOR SERVE MINISTRY, INC.
THE PRINCIPAL PLACE OF BUSINESS OF THIS CORPORATION SHALL BE 5126 East Seneca Ave., Tampa, FL 33617.

ARTICLE 11

THE PERIOD OF THE DURATION OF THIS CORPORATION IS: PERPETUAL
UNLESS DISSOLVED ACCORDING TO LAW. FILING WITH THE SECRETARY OF STATE

ARTICLE 111

THE (PURPOSES) FOR WHICH THE CORPORATION IS ORGANIZED IS (ARE):

(A) NOT FOR PROFIT CORPORATION ORGANIZED UNDER CHAPTER 617, FLORIDA STATUTES. IT IS NOT ORGANIZED FOR THE PRIVATE GAIN OF ANY PERSON. THE SPECIFIC PURPOSES OF THIS CORPORATION ARE (STATE SPECIFIC PURPOSES INCLUDING LIMITATIONS REQUIRED BY IRS) TO CARRY OUT ALL ACTIVITIES ACCORDED BY INTERNAL REVENUE SERVICE 501(C3)

(B) TO EXERCISE ALL RIGHTS AND POWERS CONFERRED BY THE LAWS OF THE STATE OF FLORIDA UPON NONPROFIT CORPORATIONS. AND THE SAME THAT ARE PRESCRIBED BY INTERNAL REVENUE SERVICE CODE 501 (C3)

(C) PROVIDED, HOWEVER, THAT THE CORPORATION SHALL NOT ENGAGE IN ANY ACTION WHICH IS NOT PERMITTED TO BE CARRIED ON BY NONPROFIT CORPORATION UNDER THE INTERNAL REVENUE CODE 501 (C3 AND NO PART OF THE NET EARNING OF THE CORPORATION SHALL INSURE TO THE BENEFIT OF OR BE DISTRIBUTABLE TO IT MEMBERS, DIRECTORS, OR OFFICERS, BUT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION TO THESE PEOPLE FOR SERVICES RENDERED, AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF ITS STATED PURPOSES. IN THE EVENT OF DISSOLUTION THE ASSETS OF SAID CORPORATION AFTER ALL DEBTS HAVE BEEN SATISFIED, WILL BE CONVEYED TO A COURT OF COMMON PLEAS IN THE LOCALE OF CORPORATE OFFICERS OR ANOTHER DESIGNATED 501 (C3 ORGANIZATION. This corporation will be a ministry.

ARTICLE 1V

THE QUALIFICATIONS FOR MEMBERS AND THE MANNER OF THEIR ADMISSION ARE:

ARTICLE V

THE NUMBER CONSTITUTING THE INTIAL BOARD OF (DIRECTORS) TRUSTEE, OR MANAGERS OF THE CORPORATION IS THREE (3) AND THE NAMES AND ADRESSES OF THE WHO ARE TO SERVE INITIALLY ARE; (NOT LESS THAN 3) Directors shall be elected as stated in the bylaws.

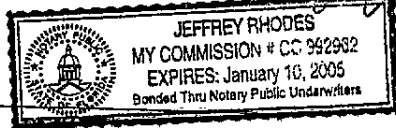
