## ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a Corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation.

#### ARTICLE I

The name of the Corporation shall be: SUNRISE RAINBOW CHILDREN'S SERVICES, INC.

#### ARTICLE II

The period of the duration of this corporation is PERPETUAL

Unless dissolved according to law. EFFECTIVE DATE OF FILING WITH THE SECRETARY OF STATE.

#### ARTICLE III

The purposes for which the corporation is organized are: To house the community activities and services of this corporation. We will serve CHILDREN and YOUTH of the MIAMI-DADE COUNTY community who are classified as AT RISK, DISADVANTAGED, and ECONOMICALLY DEPRIVED MINORITIES. This corporation will assist the identified minorities in the DECREASE, and PREVENTION of the use of TOBACCO, ALCOHOL, and other ILLEGAL, MIND ALTERING substances, from ages 9 to19. Further, this corporation will sponsor activities and services to assist The identified children and youth to increase their education and Training to employment. We will seek to build International Relationships with children of other countries worldwide, and to Increase their proficiency in the fundamentals of TECHNOLOGY FOR THE TWENTY FIRST (21<sup>ST</sup>) CENTURY.

# ARTICLE IV

The qualifications for members and the manner of their admission are:

MEMBERSHIP in this corporation will require at least a

BACHELOR'S DEGREE, and an expressed desire to assist children
and youth of the MIAMI-DADE COUNTY community under the
prescription of this corporation.

MEMBERS shall be elected by a majority vote of the BOARD OF DIRECTORS annually.
