The undersigned, acting as incorporator of a not-for-profit corporation pursuant to Florida Statutes Chapter 617, adopts the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of this corporation shall be His Shalom, Inc.

ARTICLE TWO

PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business of this Corporation shall be 2180 Everly Avenue S.W., Naples, FL 34117 and the mailing address of this Corporation shall be 2180 Everly Avenue, S.W., Naples, FL 34117.

ARTICLE THREE

PURPOSE

The general purposes for which this Corporation is organized are religious and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE FOUR

BOARD OF DIRECTORS

Section 1: The business affairs of this Corporation shall be managed by the Board of Directors. Members of the Board of Directors shall be appointed and hold office in accordance with the bylaws. The number of Board of Director members shall be governed by the by-laws but shall not be less than three (3).

Section 2: The names of the first Board of Directors are as follows:

ARTICLE FIVE

LIMITATION OF CORPORATE POWERS

The corporate powers of this Corporation are as provided for in Section 671.00302, Florida Statutes, without limitations, notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE SIX

AMENDMENTS

Amendments to the Articles of Incorporation may be proposed at any regularly scheduled meeting of the Board of Directors and adopted by a majority vote of those present.

ARTICLE SEVEN

DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon dissolution of this Corporation, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to other religious organizations.

INITIAL REGISTERED AGENT AND STREET ADDRESS



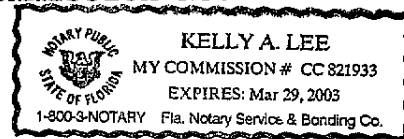

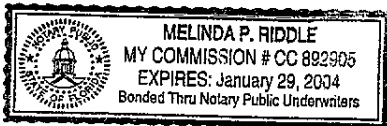
