# ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator(s) to a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

## ARTICLE I

### Name

The name of the corporation shall be: **FLORIDA'S HIV/AIDS MINISTRIES, INC.**

## ARTICLE II

### PURPOSE OF CORPORATION

The purpose of this corporation is to foster collaborative partnerships in the creation, finding, and utilizing of resources to be used in the detecting, preventing, and treating of HIV/AIDS in undeserved communities. To do everything necessary, proper, or convenient for the accomplishment of any of the purposes set forth in these Articles, and to do every other act incidental to the corporate purposes which is not forbidden by the laws of Florida or by the provision of these Articles of Incorporation. To detect the presence of, to prevent the spread of, and to holistically attend to those infected and affected by-HIV/AIDS.

## ARTICLE III

### DISTRIBUTION OF ASSETS

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Second hereof. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal

Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## **ARTICLE IV**

The Directors shall be elected by a majority vote of the Members of this Corporation.

Any such assets not so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

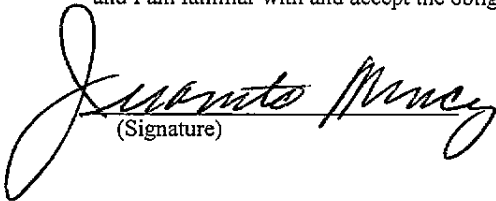
