ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

The Jacksonville French Connection for Kids, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

This purpose for which the corporation is organized is:

- raising funds to send school-age children from Jacksonville to France or other Francophone countries;
- bringing together French-speaking children and their families for meetings and cultural exchange;
- supporting French Immersion classrooms in Duval County and encouraging participation by members of francophone cultures;
- publicizing the Magnet French Immersion program currently housed at John E. Ford Elementary, #154;
- facilitating participation in cultural events such as Magnet Mania, World of Nations, the AATF-run state and national French Contest
- lobbying the school board for the creation of a dedicated Magnet school for Foreign Language Immersion, including the currently existing programs in French and Spanish;
- identifying community resources in the form of volunteer and professional workers, corporate sponsors, institutions, foundations, and parent participants who can help us to further the study and enjoyment of the French language;
- promoting the highest possible academic standards for children whose parents elect to enroll them in the French Language Immersion program;
- and for any and all other lawful purposes under Florida law.

ARTICLE IV MANNER OF ELECTION

The Directors will be elected from a slate of volunteers from among the parents of children who are current or former students of the French Language Immersion Program. Other Foreign Language professionals, business leaders with an interest in Francophone cultures, artists, musicians, and members of the Jacksonville chapter of the Alliance Française may also be elected or appointed as directors.


