**ARTICLES OF INCORPORATION**

The undersigned incorporation, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I NAME**

**ARTICLE III PURPOSES**

The specific purposes for which the corporation is organized are to provide a place to "Glorify God's Holy" name, by restoring individuals Hope and faith in a drug free environment. Absence of domestic violence, for a period of 4 to 6 weeks. The program shall provide:

- Daily and weekly counseling.
- Assistance and guidance in completing job applications, interviews and employment opportunity.
- Assistance in obtaining Medical attention
- Guidance regarding financial aid for education, housing and public assistance aid (social welfare programs).
- Temporary housing with 24 hours on sign staffing.
- A cafeteria to provide daily neution and laundry room.
- Spiritual development.
- On site nursery and gymnasium our desires are to regenerate the souls of individuals into a peaceful state giving value and meaning to every day life, giving a new beginning without control substances and violence. Transition to life as a functioning individual.

**ARTICLE IV MANNER OF ELECTION OF DIRECTIONS**

The manner in which the directors are elected or appointed is voluntary. Each director shall volunteer, than be appointed by the CEO. If necessary, a committee shall be formed to vote upon appointees.


