ARTICLE I NAME

The name of the corporation shall be:
BUILDING A COMMUNITY CONNECTION, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
5100 W. Colonial Dr. Suite 179 Orlando, FL 32808

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are:

- Provide Companion service to the developmentally disabled population.
Services consist of non-medical care, supervision and socialization activities provided to an individual on a one-on-one basis.
- Provide Supported living coaching to developmentally disabled population.
Services consist of providing training and assistance in a variety of activities to support individuals whom live in their own homes or apartments.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purpose.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The corporation shall have Voting Members, who shall be elected (and may be removed) by the voting members, and who shall have all the rights and privileges of members of the Corporation. Each voting member is entitled to one vote each, voting for new members will be conducted on a quarterly bases. Removal of a member will be conducted on quarterly bases or can be held on a case by case bases.
