ARTICLES OF INCORPORATION

ARTICLE I

The name and address of this Principal Corporation is Soul Saving Station Service Center, Inc. 1880 Washington Avenue, Opa-Locka, Florida 33054.

Purpose(s)

The specific purposes for which the corporation is organized are:
