There are no members entitled to vote on the proposed amendment. The amendment was adopted by the Board of Directors on February 2, 2006.

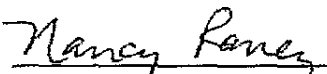

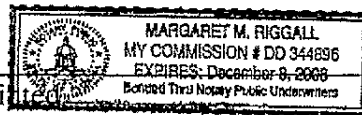
