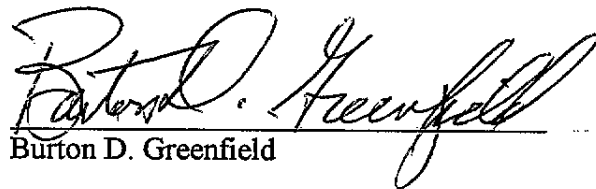

ARTICLES OF INCORPORATION
OF
DIVERSITY PLANNING INSTITUTE, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation not for profit under the laws of the State of Florida.

First: The name of the Corporation is DIVERSITY PLANNING INSTITUTE, INC. The initial place of business of the Corporation shall be: 3240 Seaward Drive; Lauderdale By The Sea, Florida 33062.

Second: The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) on the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such

organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Third: The members of the Corporation shall be determined by majority vote of the Board of Directors of the Corporation, who shall have full discretionary powers of admitting or expelling members.

Fourth: The method of election of the Directors of the Corporation shall be as stated in the bylaws of the Corporation. The initial Officers and Directors of this corporation shall be as follows:

President and Director: Beverly Kennedy

Vice President and Director: Carolyn Kennedy

Secretary/Treasurer and Director: Willowphine Ricardo

Director: Burton D. Greenfield

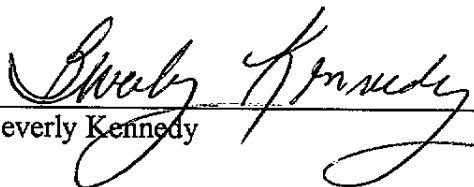

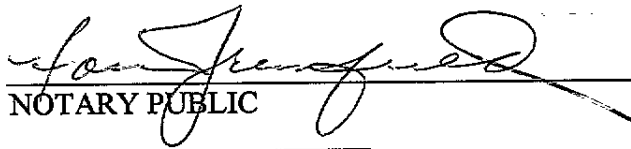
