## ARTICLES OF INCORPORATION

in Compliance with Chapter 617, F.S. (Not for Profit)

The undersigned incorporators, natural persons, acting as incorporators of a corporation under the Not for Profit Corporation Act of the State of Florida, adopt the following articles of incorporation: OLDER STREETS

### ARTICLE I NAME

The name of the corporation hereinafter referred to as the "Corporation" is:

Humane Society of Florida's First Coast, Inc.

### ARTICLE II PRINCIPAL OFFICE

The principal place of business will be 8464 Beach Blvd., Jacksonville, FL 32216. The principal mailing address will be 8464 Beach Blvd., Jacksonville, FL 32216. The territory in which the operations of the Corporation are principally to be conducted is the North Florida area but the operations of the Corporation shall not be limited to such territory, however limited to the United States of America and it's territories and possessions.

#### ARTICLE III **PURPOSE**

- No part of the net earnings of the Corporation shall inure to the benefit of any director, or 1. any member of the Corporation, or any private individual not qualifying as exempt under Section 501(c)(3) of the Internal Revenue Code, as now enacted or herein amended, except that reasonable compensation may be paid for services actually rendered to or for the Corporation affecting one or more of its purposes, or allowed by the Corporation as a reasonable allowance for authorized expenditures incurred on behalf of the Corporation, and no member, or director of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.
- No substantial part of the activities of the Corporation shall participate in, or intervene in 2. any political campaign on behalf of, or in opposition to, any candidate for public office, and
- 3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a Corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, as now enacted or herein amended.
- The Corporation shall not lend any of it's assets to any officer or director of this 4. Corporation, or guarantee to any person the payment of a loan by an officer or director of

# ARTICLE IV BOARD OF DIRECTORS

The management and affairs of the Corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the Corporation shall be defined by statute and by the Corporations By-Laws.
