ARTICLES OF INCORPORATION

ARTICLE I: NAME

The name of the corporation shall be: Islamic Dawa Foundation, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
3492-A Polynesian Isle Boulevard, Kissimmee, Florida 34647

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is: to do charitable works in accordance with the Qu'ran and taqwa, including, but not limited to, (1) carrying for the needs of travelers, widows and widowers, and orphans, (2) feeding and clothing the poor, (3) establishing and maintaining justice in the community, and (4) caring for the health of the community. This corporation shall be not-for-profit.

ARTICLE IV: MANNER OF ELECTION

The initial directors shall be appointed by the incorporator within two (2) days of the execution of this instrument; the directors so appointed will constitute the "initial board of directors." Said initial board of directors shall appoint a successor board of directors within two (2) months, in accordance with by-laws created by said initial board of directors. Thereafter the said successor board of directors shall appoint new, replacement, or additional directors in accordance with the by-laws. Provided, however, if the incorporator shall fail to appoint directors within two (2) days of the execution of this instrument, the initial officers shall serve as the initial board of directors. Provided, further, if the initial board of directors fail to appoint directors within two (2) months of the execution of this instrument, the initial board of directors shall serve as the board of directors.
