ARTICLES OF INCORPORATION

OF

DEEP WATERS CHRISTIAN ASSEMBLY, INC.

We, the undersigned subscribers to these Articles of Incorporation, each a natural person, competent to contract, hereby make subscribe, acknowledge and file these Articles for the purpose of becoming a Corporation not for profit pursuant to Chapter 617.0202, Florida Statutes.

ARTICLE I: NAME

The name of the corporation shall be Deep Waters Christian Assembly, Inc.

ARTICLE II: PLACE OF BUSINESS

The principal place of business shall be in the County of Hillsborough, State of Florida as determined by the Board of Directors. The physical address of the corporation is: 105 E. Armelia Avenue, Tampa, Florida 33601.

ARTICLE III: PURPOSE

The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under section 5019(c)(3) of the Internal Revenue Code. The charitable purpose for which this corporation not for profit is organized is as follows:

1. To assist and help members by preaching and expounding the religion of the One Living God, in accordance with the Holy Scriptures.

2. To educate and lead the people in the ways of Salvation, goodness, righteousness, morality and temperance as taught in the Bible.

3. To provide community outreach to the homeless and underprivileged people throughout the community.

#### ARTICLE IV: BOARD OF DIRECTORS

The Board of Directors shall consist of not less than five(5) and no more than nine(9) individuals from the community.

The Board of Directors shall be elected at the annual meeting of the directors and each director shall hold office for a term of three(3) years and until his or her successor is duly elected and qualified or until his or her death, resignation or removal.

Each person named in the Articles of Incorporation as a member of the initial Board of Directors shall hold offices for an initial term of four(4) years and until his or her successor shall have been elected and qualified or until his or her earlier resignation, removal from office or death.

#### ARTICLE V: REGISTERED AGENT

The registered agent of this corporation shall be Anthony Evans, 4224 Empire Place, Tampa, Florida 33610.

#### ARTICLE VI: TERM OF EXISTENCE

This corporation not for profit shall have perpetual existence.

#### ARTICLE VII: OFFICERS

The officers of the Corporation shall be the President, Vice-President, Secretary and Treasurer and other officers as provided by the By-Laws. The name of the office and the persons who are to serve as officers are as follows:

Vice-President	Annette Evans
Secretary	Alvalinda Simmons
Treasurer	Velicia Bell

#### ARTICLE VIII: BASIS OF OPERATION

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IX: DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE X: BY-LAWS


The By-Laws of this corporation shall be made by the Board of Directors and may be amended or rescinded as provided therein.

The latest edition of Roberts Rules of Order shall govern all proceedings of the corporation when not covered by the By-Laws.


