**ARTICLES OF INCORPORATION
OF
NOBLE CAUSES INC.**

The undersigned acting as incorporators of a not for profit corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation will be: Noble Causes Inc.

ARTICLE II

ARTICLE III

- {a} The purpose of this non-profit corporation shall be to provide humanitarian relief, financial and spiritual support and aid to the less privileged and disabled peoples of the world in need of such benefits, aid or assistance.
- {b} To operate exclusively, in any other manner for such spiritual, educational and charitable purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1954 as amended or under any corresponding provisions of any subsequent Federal Taxes Laws covering the distributions to organizations qualified as Tax- Exempt organizations under the Internal Revenue Code.

ARTICLE IV

EARNINGS AND ACTIVITIES OF CORPORATION

- {a} No part of the earnings of this corporation shall incur to the benefit of, or be distributable to its members, trustees, officers or any other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purpose set in this Articles of incorporation.
- {b} No substantial part of the activities of the corporation shall be carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intercede in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- {c} Notwithstanding, any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any further United States Internal Revenue Code, to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 or any corresponding provisions of any United States Internal Revenue Law.
- {d} Notwithstanding, any other provisions of these Articles, this corporation shall not accept to an insubstantial degree, engage in any activities or exercise any powers that are furtherance of the purpose of the corporation.

ARTICLE V

The manner in which the Directors of this corporation are elected shall be by general election of the membership each August. The terms of Office shall be for no less than one year for each Principal Officer of the Corporation as defined by our by-laws.

ARTICLE VI
