AMENDED AND RESTATED
ARTICLES OF INCORPORATION
FOR
FULL GOSPEL ASSEMBLY INC. OF VERO BEACH
(A non-profit corporation)

ARTICLE I- NAME

The name of the corporation shall be:
Full Gospel Assembly Inc. of Vero Beach

ARTICLE II- DURATION

The term of the existence of the Corporation is perpetual; and the corporation's existence shall commence upon the filing of these Articles by the Department of State.

ARTICLE III- PURPOSE

The specific purpose(s) for which the corporation is organized is (are):

This corporation is a religious corporation and is not organized for the private gain of any person. The specific purposes are to operate a church and to engage in religious and educational activities.

ARTICLE IV- SCOPE OF ACTIVITY

The Corporation shall have the power, either directly or indirectly, either alone or in conjunction or cooperation with others, to do any and all lawful acts and to engage in any and all lawful activities which may be necessary, useful, suitable, desirable, or proper for the attainment of any or all of the purposes for which a Corporation is organized, and to aid or assist other organizations whose activities are such as to further like purposes. Notwithstanding anything herein to the contrary, the Corporation shall exercise only such powers as are in furtherance of the exempt purposes of organizations set in 501(c) of the Internal Revenue Code of the 1954 and the regulations thereunder as the same now exist or as they may be hereinafter amended from time to time.
