ARTICLES OF INCORPORATION

The undersigned subscribes to these Articles of Incorporation, each a natural person competent, hereby associate themselves together to form a corporation not for profit in compliance with Section 617.0202 Florida Status, under Laws of the State of Florida.

ARTICLE I

The name of the corporation is:

SOUTHWEST PARKS CIVIC COALITION, INC.

ARTICLE II

This corporation is to exist perpetually unless dissolved in accordance with the Laws of the State of Florida.

ARTICLE III

This corporation may engage in any activities permitted under the Laws of the United States and of the State of Florida for the following purposes:

- 1. To exercise all the powers conferred by the Laws of the State of Florida to a not for profit Corporation.
- 2. Notwithstanding any other provision of these Articles, the purposes for which the SOUTHWEST PARKS CIVIC COALITION, INCORPORATION. is organized is exclusively religious, scientific, literary, and educational within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United State Internal Revenue Law. It is a fundamental principle of the corporation that programs developed by the corporation must benefit the community in which they reside.
- 3. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United State Internal Revenue law.

ARTICLES IV

The initial street address of the principal office of this Corporation in the State of Florida is 104 SOUTHWEST 21 WAY, FORT LAUDERDALE, FLORIDA 33312. The Board of Directors may from time to time move the principal office to any other address in Florida. This Corporation shall have the privilege of having such branch offices at such other places within the State of Florida or without the State of Florida or without the State of Florida and within the United States as may be designated from time to time by the Directors of the Corporation.
