

**ARTICLES OF INCORPORATION
OF
EQUIPPING THE SAINTS MINISTRIES, INC.**

- ONE: The name and address of this principal corporation is 941 NW 176th Terrace, Miami, Florida 33169, in Dade County. The corporation is organized pursuant to the FLORIDA Non-profit Corporation, Code.
- TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and church purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency through the spiritual education of the church. The programs will consist of but shall not be limited to : Spiritual Education, Referrals, Job Placement, Land Acquisition, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring, Care for Terminally Ill Children, Assistance to Families and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.
- FOUR: The address of the Registered office is 941 NW 176th Terrace, Miami, Florida 33169, and the name and address of the registered agent of the corporation shall be:

- FIVE:
- (A) This corporation is organized and operated exclusively for Church and Charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.
 - (B) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.


SIX: The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this corporation are:

EIGHT: On the dissolution or winding up of the corporation, it's assets remaining after payment of, or provision for payment of, all debts, and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, church or corporation, which is organized and operated exclusively for, Church and Charitable under Section 501 c (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
