**ARTICLES OF INCORPORATION
OF
INTERNATIONAL BOARD OF CHRISTIAN CLINICAL THERAPISTS, INC.
"JUNTA INTERNACIONAL DE CRISTIANOS CLINICO TERAPISTAS, INC."**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a nonprofit corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the corporation shall be
INTERNATIONAL BOARD OF CHRISTIAN CLINICAL THERAPISTS, INC.

ARTICLE II PRINCIPLE OFFICE

The street address of the initial principle place of business and mailing address of this corporation shall be 10691 N. Kendall Drive, Suite 312, Miami, Florida 33176.

ARTICLE III PURPOSE

1. To provide to the church an adjunctive ministry by competent Christian mental health professionals who respect the infallible truths of God's Word and the authentic nature of spiritual experiences as legitimate therapeutic resources for the mental health needs of believers.
2. To commission and provide ministerial credentials to pastoral and/or Christian counselors.
3. To integrate the resources of Scriptural truth and spiritual experience in a treatment modality of Christian counseling consistent with Scriptural truths and proven mental health principles.
4. To develop and offer programs embodying this modality in areas of prevention, treatment, and training through the Leadership & Pastoral Counseling Institute and/or a theological seminary.
5. To worship God, preach, teach God's word and edify the body of believers and engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.




