**ARTICLES OF INCORPORATION
OF**

The undersigned subscriber to these Articles of Incorporation, hereby submits these Articles of Incorporation for the purpose of forming a not-for-profit corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation shall be:

HARLEY OWNERS GROUP® - CRYSTAL RIVER, FLORIDA CHAPTER, INC.

ARTICLE II

PURPOSE

The Corporation's purpose shall include but not be limited to engaging in the lawful acts or activities for which a not-for-profit corporation may be organized under Chapter 617 of the Florida Statutes, as well as participation in the National Harley Owners Group Organization.

ARTICLE III

MEMBERS

The members of this organization shall be limited to those persons who qualify for, are members of, and retain membership in the National Harley Owners Group. Members of this corporation shall be admitted to membership by displaying proof of membership in the National Harley Owners Group and payment of annual dues to HARLEY OWNERS GROUP® - CRYSTAL RIVER, FLORIDA CHAPTER, INC.

ARTICLE IV

TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE V

ADDRESS OF PRINCIPAL OFFICE AND DESIGNATION OF REGISTERED AGENT

The initial address of the principal office of the corporation is to be 1803 S.E. Highway 19, Crystal River, Florida 34429, and the name of the initial Registered Agent at such address is Derek D. ARTICLE VI

DIRECTORS

The number of directors of the Corporation shall be three (3) which may be increased from time to time by the Bylaws, but shall

never be less than three (3). The Directors shall be elected as set forth in the Bylaws.

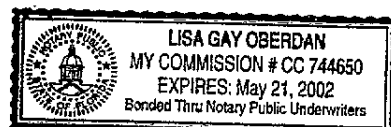




