The undersigned person, acting as incorporator for the purpose of forming a Not For Profit corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is State Pawn Association Coalition, Inc.

ARTICLE II

INITIAL REGISTERED OFFICE

The principal place of business and mailing address of the corporation is 4527 Arnold Avenue, Naples, Florida 34104.

ARTICLE III

SPECIFIC NATURE OF BUSINESS

The purpose for which this corporation is organized is to hold quarterly meetings at different locations throughout the United States. Representatives of State Pawn Associations will attend the meetings for the purpose of addressing common issues that affect all states. An agenda will be prepared prior to each meeting. A moderator will be assigned for each meeting. This activity would further the exempt purpose by educating each other and working to assist other states in the pawn industry.




