

ARTICLE I- NAME

The name of this corporation is **ORLANDO GOSPEL ASSEMBLY INC.**

ARTICLE II- DURATION

The period of its duration is perpetual.

ARTICLE III- NATURE OF BUSINESS

The purpose(s) for which this corporation is organized are: "To operate a NOT-FOR-PROFIT RELIGIOUS ORGANIZATION, TO PROVIDE ESTABLISH AND MAINTAIN A COMMON MEETING PLACE FOR THE RELIGIOUS ACTIVITIES AND ENDEAVOR OF THE ORLANDO GOSPEL ASSEMBLY. TO PREACH AND TEACH THE GOSPEL OF JESUS CHRIST: TO PROMOTE RELIGIOUS EDUCATION AND ENCOURAGE CHRISTIAN PRINCIPLES AND CHARACTER IN THE LIVES OF MEN AND WOMEN;

ARTICLE IV- MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are qualified, elected or appointed is as follows:

Each year at its General Annual Meeting, the members of the corporation shall elect a board of directors to serve for the ensuing year as provided for in the by-laws.

ARTICLE V- REGULATION OF INTERNAL AFFAIRS

The Internal affairs of the corporation are governed by the "BY-LAWS" which shall be established and approved by a majority of the directors at the first meeting of the board of directors.
