ARTICLE I

The name and address of this Principal Corporation is Fountain of Life International, Inc., 3541 S.W. 144 Avenue, Miramar, Florida 33027 Broward County.

ARTICLE II

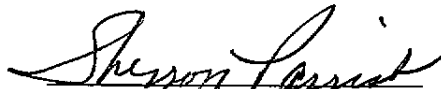
This Corporation is a Nonprofit Public Benefit Corporation and is not organized for the private gain of any person. The Corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantage individuals and families towards a life of self-sufficiency. The programs will consist of but small not be limited to: Daycare Center, Charter Schools, School of the Arts, Troubled Teen Center, Elderly Care, After Care, Job Training, Job Placement, Land Acquisition, Housing, Employment, Literacy Counseling, Temporary Shelters, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring, AIDS Awareness and Prevention, International and National Travel Tours, Survival Skills Programs, Food Distribution, Clothing Distribution, and First Aid/Medical Supplies Distribution in the Tri-County area which includes Dade, Broward and Monroe Counties.

ARTICLE III

The duration of this Corporation shall be perpetual, no stock and shall have no members.

ARTICLE IV

ARTICLE V

- (a) This Corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to carry on (1) by a Corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a Corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.

ARTICLE VI

The property of this Corporation is irrevocably dedicated to Charitable and Educational purposes and no part of the net income or assets of the organization shall ever insure to the benefit of any director, officer or member thereof or the benefit of any private person.

ARTICLE VIII

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts, and liabilities of this Corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for Educational and Charitable under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, shall be distributed to the federal government, or to a state or local government for a public purpose. Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
