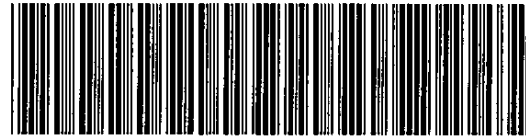

Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment(s) to its Articles of Incorporation:

AMENDMENTS ADOPTED- (OTHER THAN NAME CHANGE) Indicate Article Number(s) and/or Article Title(s) being amended, added or deleted: (**BE SPECIFIC**)

Added: Article V: Term. This Corporation shall exist perpetually or until dissolved by due process of the law. Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.

Added: Article VI. No part of the earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or the private persons, except that the Corporation shall be authorized and empowered to pay reasonable

Article VI (continued) reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof

Added: Article VII. No Substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Added: Article VIII. Notwithstanding any other provision of this document, the Corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal code, or (b) by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Added: Article IX. The by-laws of this not for profit Corporation are to be made, altered by a majority of the qualified members present and voting at any properly called business meeting at which a quorum is present.

Added: Article X. These articles of Incorporation may be amended in the manner provided by law. Every amended must first be approved by the official Board Directors. (Trustees) then approved at a duly constituted meeting called for, two weeks in advance, by the members, by a majority of those entitled to vote thereon.


