Added: Article V: Term. This Corporation shall exist perpetually or until dissolved by due process of the law. Added: Article VII. No Substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation hall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Added: Article VIII. Notwithstanding any other provision of this document, the Corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal code, or (b) by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Added: Article IX.** The by-laws of this not for profit Corporation are to be made, altered by a majority of the qualified members present and voting at any properly called business meeting at which a quorum is present.

**Added:** Article X. These articles of Incorporation may be amended in the manner provided by law. Every amended must first be approved by the official Board Directors. (Trustees) then approved at a duly constituted meeting called for, two weeks in advance, by the members, by a majority of those entitled to vote thereon.
